

Senior Financial Analyst Rotational Program – MBA

Participants in the Finance Leadership Development Program join Amazon as Senior Financial Analysts (SFAs), and are given significant responsibility from the start to drive both business and financial decisions. The China program is a unique rotational opportunity, to develop finance leaders in China. The first 12 months of the rotational program will be based in our Seattle, USA headquarters. During the 12-month US rotation, you will have an opportunity to be part of one of our US Finance teams, and learn first-hand how we build our business for US customers. Following completion of this first year rotation, you will join the Amazon China business, based in Beijing China, in a second rotation in a finance role for 12 months. SFAs are expected to evaluate and quantify new business ideas, execute controllership and reporting for their businesses, and perform data-intensive analyses, all to drive meaningful change and improvement to the way we serve our customers. Each new hire will rotate through two functional areas, as well as participate in multiple senior leadership learning sessions, so as to broaden their exposure to upper level management and to the various businesses within the Amazon family. There are opportunities for rotations at our corporate headquarters in Seattle and in our fulfillment centers across the US. After successful completion of this three-year rotational program, participants are expected to take on a senior financial leadership position supporting one of our many business units.
